Issues Finance and Accounting Teams Encounter

Setting the Stage

Spreadsheets are the lifeblood of finance and accounting departments; however, it's estimated that 88% of spreadsheets contain errors:

- Fannie Mae: \$1.1billion error in shareholder equity
- Fidelity: \$1.3billion loss was treated as a gain on a dividend estimate
- JP Morgan: *London Whale* incident netted a \$6billion trading loss due to copy/paste errors

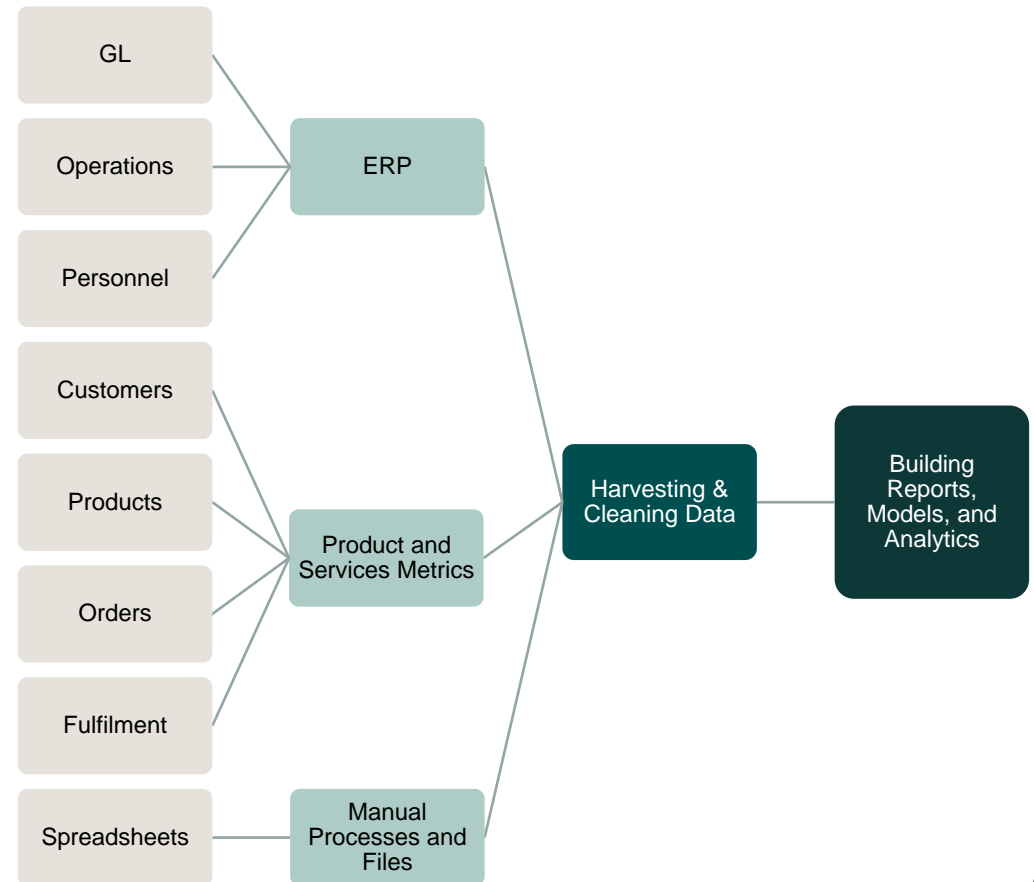

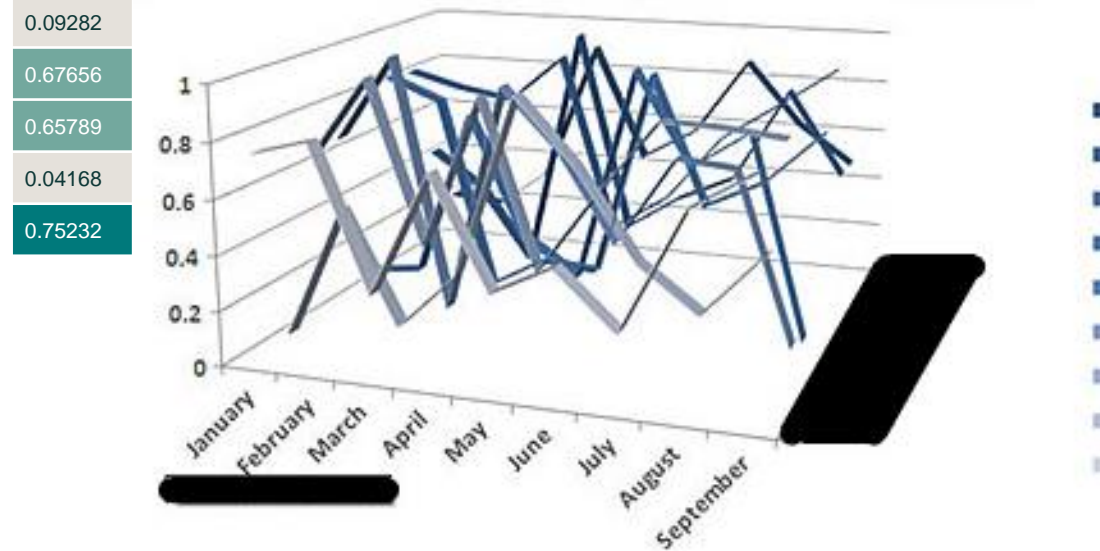

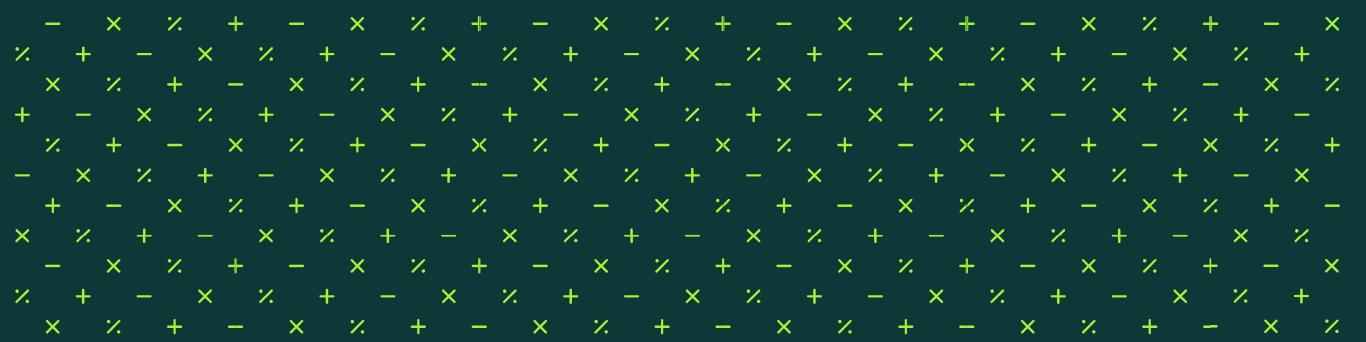


Model/Visualization Development

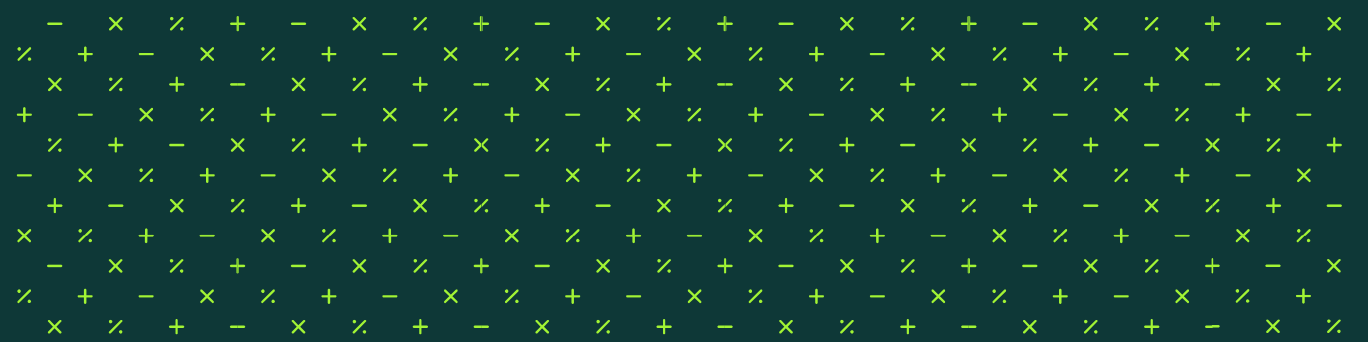
- A metric can require multiple charts to tell the full story
